Thank you for your Freedom of Information (FOI) request dated 20 May 2020, reference K/20/201.

Your request read:

“Please could you provide a list of the University's Halls of Residence in order of the most subscribed to the least subscribed. For each over-subscribed Hall, I would like to know the number of students who applied unsuccessfully, and for each under-subscribed Hall, I would like to know the number of empty/spare/available places there were. I would like this information for the annual intake of each Hall for the 2019-20 year and for each previous year, as far back as possible.”
